To celebrate its 30th anniversary, The Northern Institute for Environmental and Minority Law (NIEM) is organizing an Anniversary Seminar on "How to Develop Human and Fundamental Rights Research in Finland" in cooperation with the Human Rights Centre (HRC). The two-day event will be held in Rovaniemi and Pyhätunturi. The seminar language is English. Human and fundamental rights researchers from different fields of science are warmly welcomed and strongly encouraged to attend this highly multidisciplinary seminar.

Format

The seminar is designed to develop human and fundamental rights research in Finland using a participatory format. Participatory approach has been integrated into the planning of the seminar from its inception. The seminar will address key thematic areas of human and fundamental rights research which will be carefully selected based on the preliminary mapping of the topics and the research focus areas of the participants. The seminar is organized using an open format that allows participants to openly discuss human and fundamental rights issues among other persons with similar research interests. Structured around a mix of panel discussions, workshop and roundtables the seminar addresses key topics of human and fundamental rights research. Furthermore, the floor will be open for a minority group, the Sámi, who will have a voice of their own in human and fundamental rights research.

- Freedom of speech and hate speech


